Congratulations and best wishes as you plan for your wedding! A wedding is a special ceremony in which a man and woman come together to ask God's blessing on their new life as husband and wife. Therefore, it is especially important that the bride and groom carefully consider God's plan for marriage as well as some potential points of tension in the future. Before making any further plans, please consider several important policies:

- ❖ Two one-hour conferences with the bride and groom are required in order to discuss matters relating to the basic understanding of marriage, as well as plans for the wedding ceremony. Also, a follow-up meeting (about six months after the wedding) is highly recommended. Several premarital self-study guides can also be recommended (for example, *Before You Say "I Do,"* by H. Norman Wright & Wes Roberts).
- ❖ The church building can be used by members of the Four Lakes Church of Christ and their immediate families. Otherwise, weddings can take place just about anywhere. Please contact me for some unique ideas.
- ❖ The bride and groom must both be Scripturally eligible to be married (getting married for the first time, or all prior marriages ended either by death or divorce due to sexual sin—only the innocent person can get remarried). Any questions can be answered during the first premarital discussion (mentioned above). See Matthew 19:3-12.
- ❖ The bride and groom must not be living together in a sexual relationship before marriage. If this is the case, they must agree to separate and abstain from intimacy until the time of the wedding (1 Thessalonians 4:1-8).
- ❖ The wedding license must be in the hands of the minister at least three full days before the ceremony.
- ❖ If one of the principal members of the wedding party arrives under the influence of alcohol, at the discretion of the evangelist, the wedding will be cancelled. Anyone else under the influence of alcohol will be asked to leave the premises.
- ❖ When a couple decides to get married, it seems like everyone has an opinion as to what should take place at the ceremony. However, the minister will only listen to the bride and groom. Relationships are more important than ceremonies. A wedding lasts 15 minutes. A marriage lasts a lifetime. Please remember that the only things necessary for a wedding in Wisconsin are a bride, a groom, a license, a minister, and two witnesses. Anything else (expensive dresses, extravagant flowers, etc.) is simply ornament and is unnecessary for a beautiful and moving ceremony.

## God's Law on Marriage

---

### Matthew 19:3-12

<sup>3</sup> Some Pharisees came to Jesus, testing Him and asking, "Is it lawful for a man to divorce his wife for any reason at all?"<sup>4</sup> And He answered and said, "Have you not read that He who created them from the beginning made them male and female,<sup>5</sup> and said, 'For this reason a man shall leave his father and mother and be joined to his wife, and the two shall become one flesh'?"<sup>6</sup> So they are no longer two, but one flesh. What therefore God has joined together, let no one separate."<sup>7</sup> They said to Him, "Why then did Moses command to give her a certificate of divorce and send her away?"<sup>8</sup> He said to them, "Because of your hardness of heart Moses permitted you to divorce your wives; but from the beginning it has not been this way."<sup>9</sup> And I say to you, whoever divorces his wife, except for sexual immorality, and marries another woman commits adultery."<sup>10</sup> The disciples said to Him, "If the relationship of the man with his wife is like this, it is better not to marry."<sup>11</sup> But He said to them, "Not all men can accept this statement, but only those to whom it has been given."<sup>12</sup> For there are eunuchs who were born that way from their mother's womb; and there are eunuchs who were made eunuchs by men; and there are also eunuchs who made themselves eunuchs for the sake of the kingdom of heaven. He who is able to accept this, let him accept it."

What is the meaning of the passage quoted above?

### Ephesians 5:21-33

<sup>21</sup> ...and be subject to one another in the fear of Christ. <sup>22</sup> Wives, be subject to your own husbands, as to the Lord. <sup>23</sup> For the husband is the head of the wife, as Christ also is the head of the church, He Himself being the Savior of the body. <sup>24</sup> But as the church is subject to Christ, so also the wives ought to be to their husbands in everything. <sup>25</sup> Husbands, love your wives, just as Christ also loved the church and gave Himself up for her, <sup>26</sup> so that He might sanctify her, having cleansed her by the washing of water with the word, <sup>27</sup> that He might present to Himself the church in all her glory, having no spot or wrinkle or any such thing; but that she would be holy and blameless. <sup>28</sup> So husbands ought also to love their own wives as their own bodies. He who loves his own wife loves himself; <sup>29</sup> for no one ever hated his own flesh, but nourishes and cherishes it, just as Christ also does the church, <sup>30</sup> because we are members of His body. <sup>31</sup> For this reason a man shall leave his father and mother and shall be joined to his wife, and the two shall become one flesh. <sup>32</sup> This mystery is great; but I am speaking with reference to Christ and the church. <sup>33</sup> Nevertheless, each individual among you also is to love his own wife even as himself, and the wife must see to it that she respects her husband.
